To participate in the Flower & Garden Day, you must complete the contract below and return it by Friday, **April 17, 2020**. Fees will not be refunded.

Garden booth fees are \$175.00 per stall. Stall size is approximately 30 feet long by 20 feet deep. A certificate of insurance in the amount of \$1,000,000 with the Monroe County Fair listed as additional insured must be received by **April 17, 2020**, in order to participate in the 2020 Monroe County Fair Association Flower and Garden Day.

Craft booth fees are \$30.00 per stall and will be approximately 10 feet long by 10 feet deep. Craft vendors, as part of consideration of this contract, waive any claim of damages or liability against the Monroe County Fair, the fair manager, the fair board of directors, or its agents and employees. Vendor further agrees to hold the Monroe County Fair, the fair manager, the fair board of directors, or its agents, and employees harmless from loss or liability arising on account of the acts or omissions of the vendor.

Hours will be Sunday, May 10, 2020, from 8:00 a.m. to 4:00 p.m. Set up will be on Saturday, May 9, 2020, from 3:00 p.m. until 6:00 p.m., and on Sunday from 6:00 a.m. to 8:00 a.m. Vehicles must be moved to a designated lot after set up.

Once you have committed to the Flower & Garden Day you are expected to stay for the duration of the event (8:00-4:00). Your booth must be attended at all times.

No vendor may sublease his or her assigned space/spaces.

All vendors must clean their area and dispose of their trash.
